## MESSAGE FROM SPORT AUSTRALIA

The start of 2020 has been an extraordinarily tough time for Australians, including all of us committed to sport.

The impact of bushfires and the COVID-19 pandemic have been confronting for communities, where we all know sport plays such an important role.

At the Australian Sports Commission (ASC), comprising Sport Australia and the Australian Institute of Sport (AIS), our energy is focused on supporting our partners through these times as we continue to advocate the importance of sport to our economy, productivity, health, wellbeing and culture.

We believe whole-heartedly that when we get through this challenging period, sport will play a prominent role in lifting the nation's energy and spirits again.

Times such as these can also make us more appreciative of what we do have and of the success we have achieved.

Success in sport is always hard fought. But it's a fight Australian high-performance sport welcomes as it continues to achieve success.

Last year the wonderful Ash Barty won the French Open and became our first female No1 tennis player since her idol, Evonne Goolagong Cawley, in 1976. Javelin-thrower Kelsey Lee-Barber set personal bests throughout the year and took the title at the IAAF World Championships in Doha. Dylan Alcott added three more Grand Slam quad wheelchair singles trophies to the cabinet and Sailing duo Matt Belcher and Will Ryan claimed the men's 470 World Championship. In the pool, our swimmers won seven gold medals at the FINA World Championships, placing Australia fourth on the medal tally.

This year our inspiring women's cricket team won a fifth World T20 title, drawing a record crowd of 86,174 to the MCG. How fitting that this historical moment fell on International Women's Day. These results are a testament to the tenacity and passion of athletes, coaches, sports staff and sporting organisations, which know we have all the skills and abilities to achieve success.

I am proud too of the service our organisation provides to Australian sport each year, on behalf of the Australian Government.

The ASC, through Sport Australia and the AIS, delivers 25,000 grants a year.

The AIS, funds and prepares our Olympic, Paralympic and Commonwealth Games to represent us at the highest level in international competition.

In the past few years, we have enhanced our support to athlete wellbeing and engagement, a move that is essential, especially in the current environment.

Sport Australia invests in sports participation programs, from our national Sporting Schools program for younger children through to the Better Ageing program aimed at Australians aged 65 and over.

So many of these grants fuel aspirations. Our Local Sporting Champions program supports 9,000 children a year to reach for their sporting dreams.

Our Women Leaders in Sport program and the AIS Talent program provide opportunities for women to progress their professional development in all roles across sport.



We continue to work with sports to modernise traditional governance structures in Australian sporting organisations and we continue to encourage environments that are inclusive, diverse, safe and welcoming, making sport the benchmark for a more equitable society.

This was to be the year of the 2020 Olympics and Paralympics in Tokyo. Instead, it has been postponed to 2021, with the Olympic Games to be held from 23 July to 8 August 2021 and the Paralympics from 24 August to 5 September 2021.

We have already witnessed a great deal of positivity from athletes who now need to re-set. I'm confident, as a united sport system, we will do the same.

## **COMMONWEALTH GAMES AUSTRALIA PROUDLY INVESTING IN OUR WEIGHTLIFTERS**

Whilst not a Commonwealth Games year, the year in review has been a busy one for Commonwealth Games Australia as we build on the legacies of the Gold Coast 2018 Commonwealth Games.

Without question though the first half of 2020 has been unprecedented in our times and we recognise the challenges the COVID-19 pandemic has had on sport.

These times, highlighted by the postponement of the Tokyo 2020 Olympic and Paralympic Games, have required us all to review and re-write, and then review and re-write again, our plans and activities.

Despite having the benefit of time, with the next edition of the Commonwealth Games not occurring until July 2022, the pandemic has impacted the Commonwealth Sport Movement in Australia. The 2021 Commonwealth Youth Games were postponed and the calendar of events for 2021/22 dramatically altered. In many sports the Olympics/Paralympics will be followed by a world championships and Commonwealth Games in 2022 and whilst this will deliver an unprecedented opportunity for Australians to cheer for the Green & Gold in international competition, it will also provide challenges in what our Birmingham Chef de Mission Petria Thomas has described as a 'bumper year of sport'.

The pandemic has also impacted the organisers of the Birmingham Games, with the most notable change being the decision to not proceed with the build of new accommodation that was planned for the Games Village. Instead three smaller villages will be used in existing accommodation throughout Birmingham, in addition to the Cycling accommodation adjacent to the velodrome at Olympic Park in London. This will result in a different Games experience, but one our Team Executive of Petria, Anna Meares, Sharelle McMahon, Kurt Fearnley and Tim Mahon will creatively overcome.

Despite all this, Commonwealth Games Australia continues to focus on our 'refreshed' Strategic Plan – First Among Equals – as we embrace the future beyond Birmingham 2022 to the 2026 Games. With a strong focus on our dual vision of 'Pursuing Sporting Excellence' and 'Connecting with Communities', the Plan incorporates five strategic priorities: Delivering Team Success; Connecting with Communities; Presenting a Powerful Brand; Leading the Way; and Hosting Great Games.

To help achieve our goal of 'Delivering Team Success' Commonwealth Games Australia has been a significant financial contributor and partner for Australian Weightlifting Federation, delivering \$366,000 to the sport and our weightlifters in the lead up to the Gold Coast Games.

On the road to Birmingham 2022 our financial support continues and during the 2022 Games cycle, we have earmarked \$13m in funding to member sports through programs ranging from youth to the elite and direct athlete support. That is a significant contribution to Australian sport, for which we are proud.

Commonwealth Games Australia invested \$126,000 in 2019/20 to support Australian Weightlifting Federation's development program camps for emerging athletes.

We look forward to building on the successes of the Gold Coast 2018 campaign and continuing our work with Australian Weightlifting Federation to deliver team success together in Birmingham.

We thank Australian Weightlifting Federation and our weightlifters for their continued efforts and support.

## **PRESIDENT'S REPORT**

Following on the successes of 2019 we were all looking forward to a superb 2020, after all, we had Eileen Cikamatana, 'the force of nature', taking on and beating the best in the world, we had four or five of our athletes with solid chances of Olympic Qualifications, the emergence of young and promising athletes, our financial position strengthened, a new CEO at the helm of our Federation, our constituent States and Territories working co-operatively, meaningful progress in the re-constitution of the South Australian Association and so many other aspects of our organisation being addressed in a proper and efficient way.

We all had reason to be satisfied with our collective endeavours until in December 2019, the initial cases of some mystery virus started to surface in the Chinese city of Wuhan. By early 2020, the first confirmed COVID-19 infection was identified in Melbourne, you know the rest. Since then we have been placed in a COVID-19 induced coma.

The world stopped to a halt and sport was not immune from this devastating pandemic. The IWF had to cancel event after event, and the AWF followed suit. The Olympic Qualification was mortally affected while worldwide Weightlifting stopped. Here in our country, whilst in most States and Territories our Clubs are now operating, albeit with some form of restrictions, in our State of Victoria our Clubs are still not allowed to operate, meaning of course that many of our athletes are not able to sustain their training regime.

All tragic and none of our own doing!

On the positive side our organisation has continued to work as efficiently as possible. Our CEO, Ian Moir, has not missed a beat. The AWF is fortunate in having Ian as CEO who works relentlessly and keeps everyone informed and from the President's perspective, he keeps me briefed on a weekly basis.

Lyn Jones, as Chairman of the High Performance Commission, together with the members of the Commission have continued to maintain the level of expected service as well as keeping a watchful eye on our National Squads together with the High Performance State Coordinators. The online IWF Youth Cup is a project the Commission is heavily involved in.

The Technical side of our operation I believe is safe in the hands of Pedro Sanchez as Chairman. Together with Bowen Stuart, Ian Moir and others, Pedro has worked on innovations such as the online competitions both at International and National level which have stimulated activity and continued to generate interest amongst all athletes.

Other Directors and Commissions, too, have applied themselves equally to the tasks at hand.

Coral Quinell and her Masters Committee have remained active and planning for the major Masters Tournament in Cairns next year.

Phil Maunder brings his commercial and financial expertise to Sport Development ideas and marketing and promotions. Phil is leading a review and revamp of the AWF Website.

Boris Kayser's legal expertise is so much appreciated by the Board. The world needs lawyers and we are so fortunate in having Boris in this position. In addition to bringing his legal knowledge to the Board, Boris chairs the Anti-Doping and Integrity Commission.

Angela Wydall's contributions to the Board, particularly from an Elite Coach's point of view is immensely appreciated.

The Finance Commission and AWF Finance Manager, Danielle Waller, have our financial situation well in hand and in great shape.

Bowen Stuart, AWF IT Manager, is constantly proving to be a hidden asset as mentioned by the CEO in our last Annual Report. Bowen makes himself accessible to all and his work behind the scene is invaluable.

I wish to make a very special mention of Julian Jones, whose professional expertise is greatly appreciated by the High Performance Commission and the Coaching Commission, but also importantly for his personal advice to me and his interest in all that is Weightlifting.

## CHIEF EXECUTIVE OFFICER REPORT

The four months immediately following the last AGM were full of promise and excitement. As we headed into an Olympic year, the prospect of an increasing number of Australian weightlifters qualifying for Tokyo was very real and a good group of contenders were working their way towards achieving their Olympic dreams. Eileen Cikamatana gained her Australian Citizenship and hit the international platform wearing the Green & Gold, breaking World Junior Records and achieving a Number 1 Senior World Ranking. The Australian Institute of Sport confirmed an additional two-year funding allocation to support a Weightlifting Performance Pathway Program. The AWF delivered another Tokyo 2020 Olympic Qualification Event in the form of the Australian Open. Our domestic competition program promised to engage weightlifters of all levels through Club and State events in every Australian State and Territory, and National events were planned for delivery in ACT, WA, TAS, QLD, and NSW.

And then everything changed. As the Australian Team prepared to travel to Nauru for the 2020 Oceania Championships, the reality of what we now know as the COVID-19 Pandemic hit home. Borders closed; clubs and gyms closed, and sport was suspended indefinitely. Uncertainty became the order of the day.

The AWF's first reaction to all of this was to take a 'watch and act' approach. The Board of Directors and staff, in consultation with the State Members and AWF High Performance Commission, took stock of the situation in each State and Territory and established a set of guiding principles to inform a delay/postponement/cancellation plan for 2020's national events. As time went by, all contingencies were eventually exhausted, and we were left with the sad realisation that there would be no Australian Weightlifting Championships in 2020.

As States and Territories began to emerge from the restrictions imposed by their governments in response to COVID-19, the AWF's focus turned to supporting a return to training and competition. Guidelines for conducting weightlifting in a COVID-Safe manner were developed and distributed; and State Members were offered a rebate on capitation fees to assist with the additional costs of bringing the sport back to life.

After three months of lockdown, Western Australia began holding live competitions again at the end of June. Tasmania, Northern Territory, Queensland and New South Wales followed in July. Lifters in South Australia and the ACT were back on the platform in August, but on the eve of Victoria's return, severe restrictions were imposed in that state once again and only now, at the beginning of November, are Victoria's weightlifting clubs preparing to reopen.

The membership data contained within this report shows a decrease in capitations compared to last year, which is not surprising considering the effects of the pandemic. However, the overall decline in membership is not as severe as expected and some States have even increased their membership.

Throughout this period, the AWF, like every National Sporting Organisation, has faced unprecedented challenges and I would like to thank the Board of Directors and particularly the AWF President Sam Coffa, for their responsiveness in an ever-changing environment. When quick decisions needed to be made, the Directors devoted their immediate attention to the issues at hand and would often achieve a resolution the same day via electronic communication methods. All Board members have made themselves highly available and their diligence makes the CEO's job so much easier.

Looking to our International Federation, the release of the McLaren Report set in motion a dramatic series of events that have been well publicised elsewhere and I won't rehash them here. The International Weightlifting Federation has much work to do in many important areas and it's significant to note that the IWF Executive Board called upon our own President, Sam Coffa, to guide and advise them as they work through the reform process. The IWF also appointed Sam Coffa as the IF Liaison to the Commonwealth Games Federation; and as the Technical Delegate for the Tokyo 2020 Olympic Games and the Birmingham 2022 Commonwealth Games. The IWF recognises the wealth of knowledge and experience that Sam possesses, and we are truly fortunate to have him guiding the AWF as our federation's President.

Financially, the AWF maintained a strong position. Despite a significant loss of revenue from the cancellation of coaching courses and events, funding support from the Australian Government, through the AIS, continued on schedule, and unexpended High Performance funding is permitted to be rolled over to the next financial year. In a

nutshell, the AWF's bank balance grew because of not being able to spend on team travel, training camps and events, which is a good indicator of where the AWF's priorities lie.

Danielle Waller continues to provide the AWF with expert financial management on a day-to-day basis and budgeting advice over the longer term. This year, Danielle moved the AWF's accounting system to MYOB Essentials online, which provides me as CEO with immediate access to 'the books' at any time. Danielle also attended the regular online meetings of the Sport Finance Network, which is the funding and financial advisory section of Sport Australia. The information provided in these meetings was particularly important at the height of the COVID lockdown, ensuring that the AWF remained up to date with the regulations applicable to government assistance packages, new reporting arrangements, financial data collection, etc. The AWF also moved its banking business to Westpac this year, in pursuit of better service and greater returns. I thank Danielle for her support and advice, and for her hard work in this vitally important area.

Bowen Stuart's name appears often in this annual report and that is because Bowen's work underpins many parts of the AWF's operations. While he's generally thought of as an I.T. specialist, Bowen also has a Masters Degree in Business and he brings his expertise in these two fields together with his knowledge of weightlifting to design and implement solutions for the AWF in Coach Education, Officiating Education, Promotions and Marketing, Event Management, Database Management, Communications... and the list goes on. My sincere thanks go to Bowen for all that he does for the AWF on a daily basis.

In closing, I wish to place on record my thanks, again, to AWF President Sam Coffa and the Board of Directors for their strong leadership and attention to all aspects of the organisation's governance. I wish to also acknowledge Matt Carroll, CEO of the Australian Olympic Committee and the AOC personnel who are forging ahead with plans for Australia's participation at the Tokyo Olympic Games in 2021. Finally, I thank the State Members for their patience and cooperation throughout what has been a very tough year for all of them and I hope that we will continue to work effectively together in a brighter future.

## HIGH PERFORMANCE PROGRAM REPORT

2020 has been a most difficult year for our sport for all members. Our HPC only managed one face – to – face meeting in January prior to the virtual “shutdown” due to the Pandemic. This meeting was held in Melbourne and covered a multitude of subjects. The HPC has kept in contact throughout the rest of the year by email and phone calls.

Many decisions and plans made at the January meeting were unable to be realized. Our National Championships in all age groups have had to be cancelled, as too have the international events to which we were hoping to enter teams. Training Camps planned for the AIS for Senior, Junior & Youth Squads and especially the Performance Pathway Program have been unable to take place.

Not reflecting too much on the “gloom and doom”, several initiatives were successfully carried out.

The production of a Job description for the Pathway Program Manager was approved and EOIs sent out. Initially, Paul Coffa considered the position, but decided that his talents and energy would be better used in other areas of High Performance. The eventual appointee was Greg Hobl and all wish him well in the position.

As Greg was the State High Performance coordinator for Queensland & NT a replacement was needed and two highly qualified applications have been received and the BOD Directors & HPC will make a decision very soon on an appointment.

Our Squad system, which started well, ground to a halt other than the Super Squad still receiving their stipends. It was decided to continue with the current Squad members until the pandemic allowed the various State restrictions to be eased. This has gradually come about – except for Victoria – and we have had Squad lifters competing in State competitions. Several producing improved results.

As several of our Super Squad lifters had achieved Elite status the HPC requested the BOD to increase the monthly stipend for them. This was agreed and they now receive \$1200/month. We now have 4 Elite standard lifters with others close. See Squad lists later.

The problems with the IWF have cast a shadow over the Olympic Games qualifying criteria and we still do not have a conclusion to this.

However, the 2022 Commonwealth Games criteria have, at last, been defined. This is in no small way due to the efforts of our President who has been appointed by the IWF as their Weightlifting Liaison. With these criteria now at hand the HPC have a challenge in preparing our potential team for the event and hopefully realizing our objectives in the medal count.

The HPC with BOD agreement, placed Eileen Cikamatana and Charisma Amoe–Tarrant at the AIS/ACTAS for training. Eileen was stuck in quarantine in Sydney after her return from New Caledonia and not able to travel on to Melbourne. She was at the AIS from June to the end of October. She is now training in Sydney. Charisma – who was having problems staying focused in Brisbane, spent 9 weeks at the AIS, improved her overall condition and returned to Brisbane to compete at the Qld Championships where she recorded an Elite total (2nd best ever).

With domestic conditions now allowing for official competitions again – at the moment only in state events – the HPC will now consider re-vamping the Squad system with more specific criteria for 2021.



Once an international calendar is confirmed and international travel again allowed, we can plan accordingly.

## TECHNICAL COMMISSION REPORT

What a year for all of us, a year that we were all looking forward to, the year of the Olympics the pinnacle of our sport. Let's hope that the Olympic Games do go ahead next year, which by all indications based on announcements by the IOC they should.

Since our last AGM we have not had many International Competitions, indeed there has only been a handful: the Lima World Cup, the Peru World Cup, the Pacific Cup and the Australian Open, where Australian Technical Officials have participated.

The Technical Commission has had a very successful year. After well prepared submissions by our CEO, Ian Moir, and our Information Technology & Communications Manager, Bowen Stuart, with input from Members of the Commission we received \$2,500 AUD in Olympic Solidarity funding from the IOC (via the AOC); and 6,000 USD from the IWF Development Program. The submissions were submitted in an endeavour to receive funding so as to enable us to develop the capability in Australia to have the Video Playback Technology (VPT) as close as possible to that which is currently in use by the IWF at World Championships.

With a lot of work by Bowen we now have a system which has been trialled in a number of competitions in Queensland, to date one of the few states that has been able to hold competitions in the usual way. Once we return to the "normal" post COVID-19, we hope to start using the VPT system at all our National events and train Technical Officials who have an interest in the use of this new Technology.

The VPT system in conjunction with videos taken at each of our National events will also assist in the training of Technical Officials and the improving of Officiating at all levels from beginners to Elite. We also believe the VPT and additional videos will be a good resource for coaching development and education.

The funding has also been used to develop the AWF Online Technical Official Education Course as a resource for the states to develop Technical Officials from Club to National grade.



During COVID-19 Sam Coffa, Bowen Stuart and myself have been involved in delivering a number of Officiating Seminars in Oceania as well as in other Continental Federations.

In closing I would like to thank my fellow Technical Commission members, Sam Coffa, Phil Maunder, Ian Moir for their contribution and support throughout the year, and a special mention to Bowen Stuart for making the VPT and Technical Officiating Courses a reality, thank you Bowen.

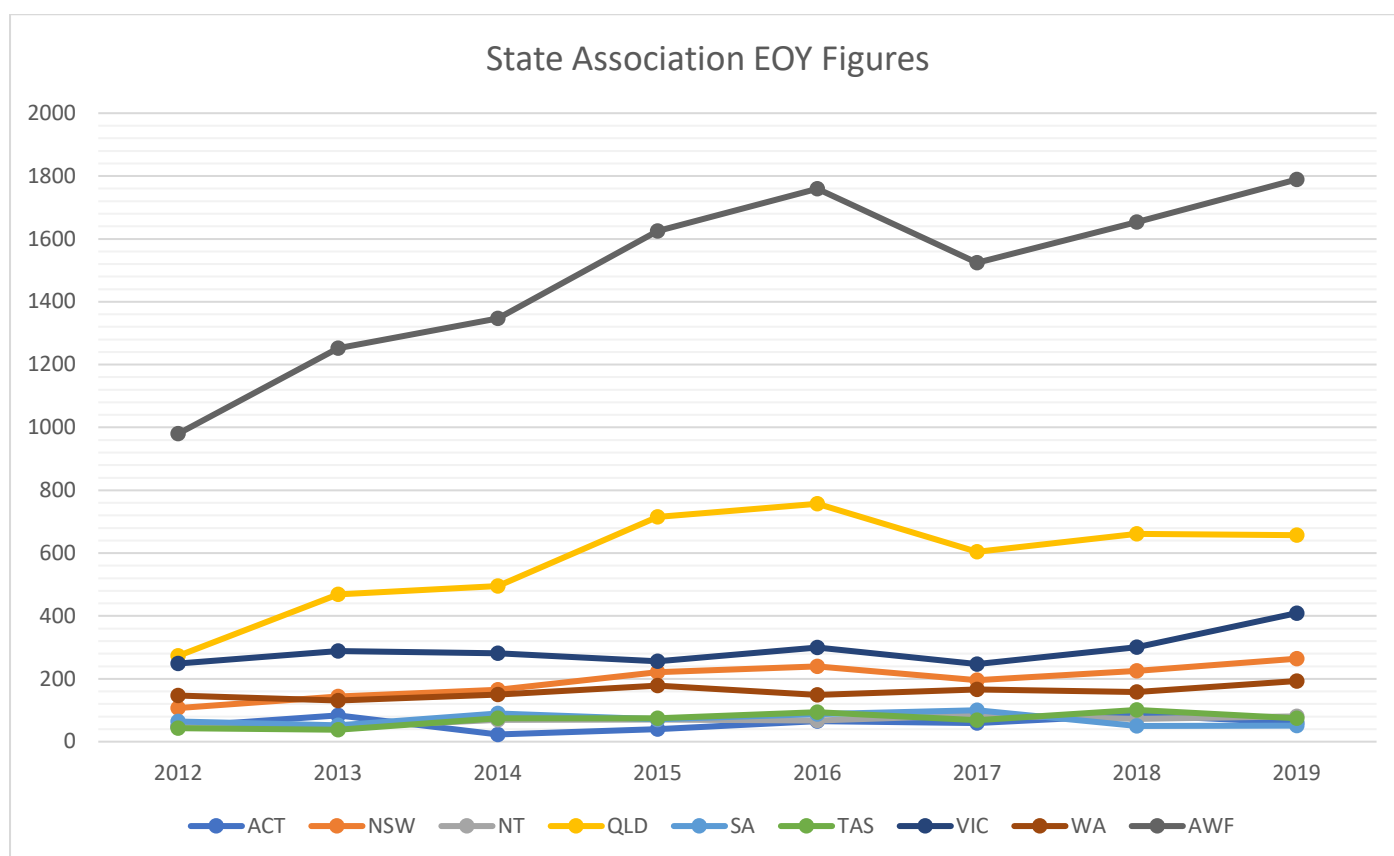

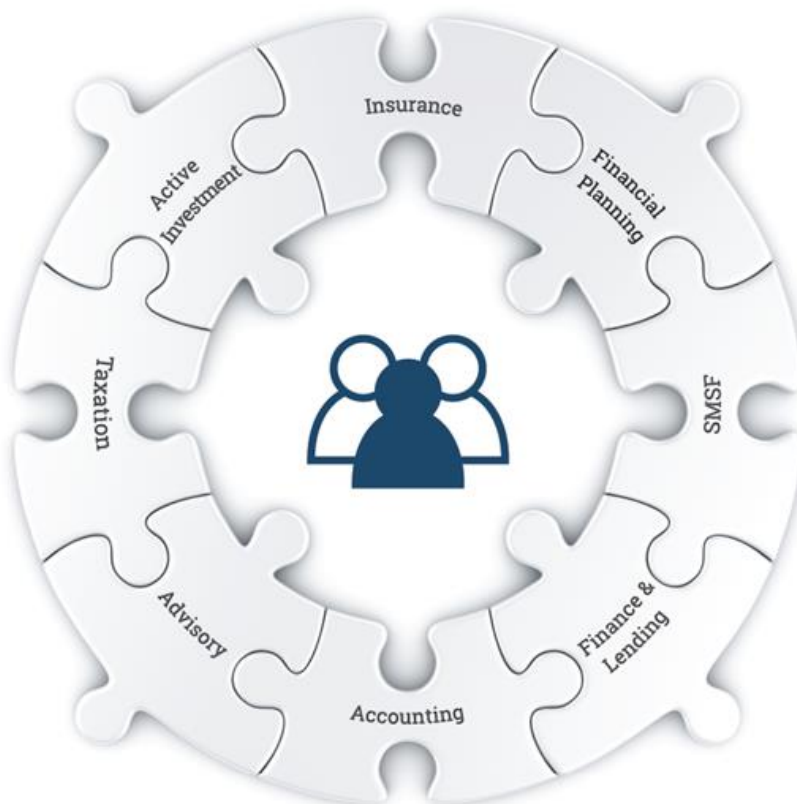

**NOTES TO THE FINANCIAL STATEMENTS**

**FOR THE YEAR ENDED 30 JUNE 2020**

**1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The director has prepared the financial statements on the basis that the company is a non-reporting entity because there are no users dependent on general purpose financial statements. The financial statements are therefore special purpose financial statements that have been prepared in order to meet the needs of the member.

The financial statements have been prepared in accordance with the significant accounting policies disclosed below, which the director has determined are appropriate to meet the needs of the member. Such accounting policies are consistent with the previous period unless stated otherwise.

The financial statements have been prepared on a cash basis and are based on historical costs unless stated otherwise in the notes. The accounting policies that have been adopted in the preparation of the financial statements are as follows:

**(a) Income Tax**

The entity is not liable for income tax.

**(b) Property, Plant and Equipment**

All property, plant and equipment except for freehold land and buildings are initially measured at cost and are depreciated over their useful lives to the company.

The carrying amount of plant and equipment is reviewed annually by the directors to ensure it is not in excess of the recoverable amount. The recoverable amount is assessed on the basis of expected net cash flows that will be received from the asset's employment and subsequent disposal. The expected net cash flows have been discounted to present values in determining recoverable amounts.

Freehold land and buildings are carried at their recoverable amounts, based on periodic, but at least triennial, valuations by the directors.

**Depreciation**

The depreciable amount of all fixed assets, including buildings and capitalised lease assets but excluding freehold land, is depreciated on a straight-line basis over the asset's useful life to the company commencing from the time the asset is held ready for use.

**(c) Goods and Services Tax (GST)**

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the statement of financial position.

**(d) Committee Reporting**

The committee recognises that it is a Tier 2 reporting organisation.

**(e) Revenue and other income**

The core principle of AASB 15 is that revenue is recognised on a basis that reflects the transfer of promised goods or services to customers at an amount that reflects the consideration the Organisation expects to receive in exchange for those goods or services. Revenue is recognised by applying a five-step model as follows:

1. Identify the contract with the customer
2. Identify the performance obligations
3. Determine the transaction price
4. Allocate the transaction price to the performance obligations
5. Recognise revenue as and when control of the performance obligations is transferred

The revenue recognition policies for the principal revenue streams of the Organisation are affiliation fees, coaching accreditation fees, sponsorship, competition, games revenue and merchandise sales. These amounts are recognised as revenue when control of the performance obligation have been transferred.

**(f) Financial instruments**

Financial instruments are recognised initially on the date that the Organisation becomes party to the contractual provisions of the instrument.

On initial recognition, all financial instruments are measured at fair value plus transaction costs (except for instruments measured at fair value through profit or loss where transaction costs are expensed as incurred).

**Financial assets**

All recognised financial assets are subsequently measured in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

*Amortised cost*

Assets measured at amortised cost are financial assets where:

- the business model is to hold assets to collect contractual cash flows; and
- the contractual terms give rise on specified dates to cash flows are solely payments of principal and interest on the principal amount outstanding.

The Organisation's financial assets measured at amortised cost comprise trade and other receivables and cash and cash equivalents in the statement of financial position.

Subsequent to initial recognition, these assets are carried at amortised cost using the effective interest rate method less provision for impairment.

Interest income, foreign exchange gains or losses and impairment are recognised in profit or loss. Gain or loss on derecognition is recognised in profit or loss.
